



## CALL FOR ARTISTS

### NO PLACE IS FAR

The cultural association DAPHNE organizes the international exhibition NO PLACE IS FAR. The exhibition will be inaugurated in the year 2022.

#### **Exhibition**

- **All the works participating to the call** will be exhibited at the Rocca Sforzesca, Soncino (Cremona), Palazzo Bargnani - Dandolo, Adro (Brescia) or any other prestigious historical locations in Italy
- **50 works** will **also** be selected and exhibited at the Gallery La Nacional in New York.
- **And further 30 works** will be selected to form the artist's sketchbook which will be shown at the Brooklyn Art Library in New York.

The 50 artists selected for the exhibition at La Nacional in New York will have their CV and photos of the work published in the magazine [Arte News Publications](#), an art and music magazine based in New York and directed by the New York Curator **Paul Cabezas**, disclosed at the most important American and European art fairs in New York, London, Spain.

The list of all the artists who will exhibit in the exhibition NO PLACE IS FAR will be published in the Arte News Publications magazine of New York.

All artists will receive the paper magazine by post.

The 30 artists selected for the Brooklyn Art Library of New York will see their original work published in the paper book sketchbook of the library collection, which will produce a digitized book to be used by each artist.

#### **ADMISSION REQUIREMENTS**

The call is open to artists from all over the world who propose a work on paper, made with painting techniques, pencil or pen drawing, collage of papers, etching, as expressive means of contemporary art.

The work must correspond to the following definition: original work, handmade, made on paper, two-dimensional, measures 5 " (12,7 cm) x 7 " (17,78 cm).  
The use of passe-partout and frame is prohibited. The work on paper must not be glued to cardboard or other support.

The admission of the work to the exhibition is subject to the unquestionable selection made by an International Jury, directly appointed by the Cultural Association DAPHNE

Shipping with insurance coverage of one 's own work to the headquarters of the Cultural Association DAPHNE (which will be communicated by email).

Payment of the registration fee

Within the promotion and communication activities, the organization reserves the right to create images and video footage and / or use related information.
